

ONGOING DIGITALISATION (1)

- In recent years, EU has promoted the possibilities for electronic exchange of information in cross-border transactions and exchange of evidence
 - European Commission has supported the e-CODEX Project, developed the e-Justice Communication via Online Data Exchange (e-CODEX) System
 - Regulation (EU) 2022/850 has been adopted defining the roles, responsibilities and legal framework for operating the e-CODEX System
 - Back in 2016, based on e-CODEX, Commission decided to initiate the development of e-Evidence Digital Exchange System (eEDES), also known as Reference Implementation Software, to pilot the support of digital exchange of European Investigation Orders (EIOs), Mutual Legal Assistance (MLA) forms and Interception of Telecommunication Notifications (ITNs)
 - So far 11 member states has joined the digital exchange of EIOs in a piloting mode (AT, BE, DE, ES, FR, HU, LU, LV, PT, PL, SI)


ONGOING DIGITALISATION (2)

- In December 2021, a legislative proposal package on the digitalisation of judicial cooperation was adopted resulting in – among others – **Regulation (EU) 2023/2844 on the digitalisation of judicial cooperation and access to justice in cross-border civil, commercial and criminal matters, and amending certain acts in the field of judicial cooperation** (in force from Jan 2024, apply from 1 May 2025) amending 8 legislative acts in judicial cooperation
- Regulation (EU) 2023/2844 delivers on new rules allowing:
 - the participation by parties and other relevant persons in oral hearings in civil, commercial and criminal proceedings by means of videoconferencing or other distance communication technologies
 - electronic communication between natural or legal persons or their representatives and competent authorities
 - the recognition of documents with electronic signatures or seals
 - the payment of fees through electronic means.

ONGOING DIGITALISATION (3)

- According to Regulation (EU) 2023/2844, the communication pursuant to a total of 24 legislative instruments in the field of judicial cross-border cooperation and access to justice in civil, commercial and criminal matters, including the exchange of forms established by those acts, shall be carried out through a secure, efficient and reliable decentralised IT system (ref. the e-CODEX System).
- Member States should be able to use the software developed by EC (Reference Implementation Software) instead of a national IT system.


Roadmap for eEDES

Video or telephone conference: Procedural Stage When a Hearing Can Be Asked



HEARINGS BY
VIDEOCONFERENCE
PROCEDURAL PHASES



- 1 Investigation
- 2 Trial
- 3 Appeal

With regards to **hearing by videoconference in the trial phase**, the question has been raised as to whether the EIO could be used for the hearing of accused persons during trial and thus as a way to guarantee the participation of the accused in a criminal trial instead of a temporary transfer (Section H1 of an EIO form). **Recital 25** *z* of the EIO Directive confirms that the Directive covers all stages of criminal proceedings, including the trial phase.

Hearing of an accused by videoconference in the trial phase cannot however be used by those Member States whose domestic law requires the actual presence of the accused at trial. This same measure might also not be used, in the same circumstances, by those Member States that can only use videoconferences for the gathering of evidence. These countries may, however, execute such EIOs


TREIO ENVIRONMENT

Set-up

- A full e-CODEX gateway is setup for TREIO
- The TREIO eEDES Simulator sends messages through this gateway and is available for training – **no national implementation required / access is provided by TREIO**
- This TREIO eEDES Simulator is able to communicate with another e-CODEX gateway (the e-CODEX CTP) for real-time training
- Coordination via the TREIO LMS + the TREIO Auto-Responder




How To...? (1)

USE CASE 1: OUTGOING EIO

Users interact with the TREIO eEDES Simulator (<https://treio2.ee.auth.gr>) assuming the role of the *Issuing State*, in our case the “eEDES Simulator”.

The role of the *Executing State* is taken by the “TREIO Auto-Responder” which responds to incoming requests.




How To...? (2)

USE CASE 2: INCOMING EIO

Users interact with the TREIO eEDES Simulator assuming the role of the *Executing State*.

Different incoming Annex A cases can be “ordered” through the TREIO Auto-Responder’s environment (the *Issuing State*) to the Executing State, at the request of the user (via <https://eiotest2.ee.auth.gr>).






